

ENPUD Strategic Plan for 2022 - 2024.

Adopted by the General Meeting of ENPUD June 2022.

Strategic Objectives	The rationale for prioritizing to achieve Legality and Safety of People Who Use psychoactive substances through the implementation of informed and evidence-based drug policies in EECA for the use of psychoactive substances for pleasure and/or for medical purposes.
Development of unity and professional competencies of the Community	30% of resources should be invested in supporting, developing, and building a unified ENPUD Community team in which everyone is willing to participate meaningfully; form a supportive environment; learn to listen to each other; validate work; and give constructive feedback.
Changing public perceptions of people who use drugs	20% of resources should be invested in changing public opinion. We need the support of the expert community in the countries, family and friends of people who use drugs; the open faces of Community members. As of today, self-stigma and stigma are very much in the way of us moving toward a strategic goal. Therefore, we will devote 20% of our resources to changing the attitudes of Community members toward their lives and to conducting systematic public campaigns, involving people who influence the opinions of different groups of citizens of EECA countries.
Organization of the system of care and access to treatment in emergency situations	20% - this strategic plan was developed during the coronavirus pandemic, Russia's war against Ukraine, and an attempted coup d'etat in Kazakhstan. The main problems that arise during emergencies: 1) reduced or no access to medication and/or treatment; 2) risks of deprivation of life and/or liberty for ENPUD activists by repressive regimes of some EECA governments; 3) Lack of ENPUD shelters and resources to evacuate activists for the duration of the persecution.
Humanization of Drug Policy Legislation and Law Enforcement	30% of resources need to be systematically invested in changing drug policy, because harassment by law enforcement is a major problem for our community that creates stigma and discrimination.

1.1.	Personal Growth of ENPUD Community Members	Why: To pump up self-confidence and the strength of the Community, to get rid of self-stigma, guilt and shame imposed by repressive drug policy. To provide opportunities to maintain and improve health, technical support, quality participation in profile events.

		 1.1.1. Approval of the membership capacity building plan - by the end of 2022. 1.1.2. A system of monitoring personal growth of ENPUD members was created - tracking the dynamics of development of Community members, including a decrease in self-stigma; increases in profile competencies; meaningful participation in the life of the ENPUD community - 2023. By the end of 2024, 50% of ENPUD members have done the work together and reflected on the lessons learned. 1.1.3. All ENPUD members meet at least once a year - every year; 1.1.4. Holding joint face-to-face meetings through educational and internship programs. 1.1.5. Provide for emergency medical needs of ENPUD members - annually for 25% of ENPUD members. Cover essential needs by 2024.
1.2.	Developing the expertise capacity of the ENPUD Community	Why: The ENPUD development approach is the formation of thematic Expert Councils consisting of ENPUD members. Within the framework of the Expert Council, competencies on a given topic are enhanced; sustainable links are formed between ENPUD members from different countries in the region; research and evidence base for working with partners and governments are created. How we work and the timing indicator:

		 Development of ENPUD Expert Council on Treatment: systemic fundraising for continuation of work; competency building for working with pharma companies; MOH; impact on prevention of procurement disruptions; forming thematic partnerships - annually. Organization and development of ENPUD Expert Council on Rights and Drug Policy 7 people team - end 2022; annual support of ENPUD's ECRD work. Organization and development of the ENPUD Institutional Service: a team that works to systematically serve the ENPUD Community: 2022 - voting to update the Charter, Strategic Plan 2022-2024; systematically open competitions for positions with priority for ENPUD members with equal qualifications or the ability to quickly upgrade qualifications.
1.3.	Creating conditions for practical experience of life without stigma and discrimination: internships in countries with humane drug policies.	 Why: The majority of ENPUD members live in countries with repressive drug policies and often accept stigma and discrimination as the norm. Internships in countries with progressive drug policies provide an opportunity to experience firsthand the differences in attitudes, perceptions, and opportunities for people who use drugs to live according to their personal preferences; to seek help; and to maintain their rights as citizens. How we work and the timing indicator: 1.3.1. Internship of the Expert Council on Treatment - 2023 (country to be determined by objectives) 1.3.2. Internship of the Expert Council on Rights and Drug policy - 2023 (country to be determined by objectives) 1.3.3. Participation of ENPUD members in European festivals, events, and conferences - annually.

Why: Create an environment that encourages support and assistance; constructive criticism and meaningful participation in the development of the Organization. Attention to the actions of Community members, open feedback, and a willingness to personally change in order to maintain unity and the ability to act together. How we work and the timing indicator: 1.4.1. Organization of the work of the ENPUD Ethics Committee - 2022 1.4.2. Holding meetings on the ENPUD Code of Ethics Monitoring the practice of the ENPUD Ethical Principles by ENPUD members - every six months

Why: To engage allies, partners, volunteers, and opinion leaders in achieving the Strategic Goal, the ENPUD Community must be as transparent as possible in its actions, financial and programmatic activities. Each individual at ENPUD has the opportunity to learn and participate in the development of all regulations, projects, work plans, and participate in their implementation on an equal and open basis.

	working to break down stigma	2.2.1 We adopt a communications strategy (by the end of 2022) that spells out the key messages that we all work together, time after time, to communicate to society.
		2.2.3 The Communications Department revises materials on ENPUD's website and social media. Editing them according to the communication strategy we have adopted. Helping national organizations with this. Until April 2023.
		2.2.3 By the efforts of the Communications Department and in partnership with national organizations, we conduct at least four large-scale public awareness campaigns in 2023 and 2024. Involve celebrities, experts, media, and activists from the community. We use dates that are meaningful to us: May 2 - ENPUD Memorial Day (the day Alyona died), March 8 - Narcofeminism; May 19 - HIV Memorial Day, June 26 - Support Not Punish, July 21 - Memorial Day for the Victims of Drug Repression, August 31 - Overdose Awareness Day, November 1 - Community Day for People Who Use Drugs, and December 10 - Human Rights Day.
		2.2.4 At the end of 2022 and thereafter on a quarterly basis we measure the number of publications on our topic, as well as the ratio of positive to negative publications (brand analytics).
		2.2.5. We track the number of publications from experts and activists who are willing to speak out publicly in support of drug policy change - once every six months.

3. Organization of the system of care and access to treatment in emergency situations

What we do		Why: Know how to act, have resources available to be prepared for emergencies.

How we work and the timing indicator: 3.1.1. Creating a separate account for emergency assistance to ENPUD members (prioritized by active ENPUD members). Placing these funds on the deposit and receiving interest on the deposit. If necessary, withdraw it from the account at any time. In ENPUD projects, we set aside a minimum of 10% of the project amount for the Emergency Relief (Aid) Fund; we conduct advocacy among donors to understand the importance of having an Emergency Relief Fund. 3.1.2. Adopt Regulations on the use of the Emergency Relief Fund: conditions, terms, responsible persons - 2022. The regulation includes: Formation of a system of requests from the country where the emergency situation occurs; Create a procedure for sending and reviewing requests for emergency aid. By the end of 2022. Review of applications - ENPUD Board so that money from the Emergency Fund can be used for housing, visas, medications, closing basic needs, tickets, and legal assistance if needed. 3.1.3. By the end of 2022, conclude contracts with partner organizations that have their own shelter. 2023 - determine the need to create a shelter for the ENPUD community. Choice of country: EU, with humane drug policy, with normal diplomatic relations with EECA countries; with access to all medicines; in this country to make a shelter - a place of gathering. 3.1.4. Creating a database of all human rights and humanitarian organizations. Concluding contracts. The task of the Expert Council on Rights and Drug Policy for 2022 - 2023.

Evaluating the quality of the devices ENPUD members use; through ENPUD and country resources, improving the quality and reliability of computers, phones, microphones, any device needed for the work of an ENPUD human rights activist - by 2024 50% of all active ENPUD members have been able to upgrade their working tools.

4. Humanization of Drug Policy Legislation and Law Enforcement Practice

What we do		Why: how we do and Indicators by timing
4.1.	Engaging in direct dialogue with decision makers in the countries of the region	Why: We understand the reality of the situation and are ready to offer an action plan that will reduce the number of addicts or people with problematic use; increase substance use awareness among people who live in poverty, who are traumatized, who live under the pressure of stigma and discrimination, and who use substances as a tool for self-medication.
		 4.1.1. ENPUD is part of the Regional Commission on Drug Policy: officials and former Prime Ministers who are willing to promote humane policies in the region, [are attracted] for activities in the countries of the region, using the authority of the Regional Commission - end of 2023. 4.1.2. Join national delegations to the CND International Commission on Drug Control. 1 ENPUD country in 2023; 2 countries in 2024. 4.1.3. Creating Position Papers with publication of schemes of corruption and the negative impact of repression, including case studies to show holes in the law and law enforcement practice and to get laws changed/implemented - one ENPUD Position Paper on drug policy per year - March 2023, March 2024 with tracking of progress or regression in the response of relevant government services.

4.2.	Forming a monitoring system that tracks the compliance of the Ministry of Health and Narcocontrol (Drug Control office) with their stated goals.	Why: The experience of the Czech Republic and Portugal has shown that changes in drug policy are possible with systematic monitoring of the consistency of the state's actions with the declared objectives. In every country in EECA, the goals of drug policy coincide with the goals of ENPUD: to preserve people's health and social well-being. However, the means currently used by the drug control agencies of the EECA countries are alienating the states from achieving their stated goals. Systemic monitoring will reveal problem areas and become the basis for open discussions and practical steps to change drug policy. How we work and the timing indicator:
		4.2.1. Forming a simple monitoring system that tracks the compliance of the Ministry of Health / Drug Control's actions with their stated goals - mid-2024.
		4.2.2. Finding in governments those, interested in health and well-being of the country's citizens, members of parliament or the prime minister, or someone of influence. We need smart advisors. With their support we understand how the results of our monitoring can be used to make changes in drug policy norms and practices that will save us. Understanding the options of who these people are, motivate and [act] - 1 to 3 countries in 2023- 2024.
4.3.	Forming proposals to change drug policy practices with community-led pilot projects.	Why: International practice has enough effective experience, which can be offered in the form of models to adapt effective models for EECA countries. The ENPUD Regional Network finds resources and, under community management, can implement pilot models (problem drug use prevention instead of probation; substance testing as part of risk reduction, etc.) with the help of international experts. How we work and the timing indicator:
		 4.3.1. Based on the results of monitoring, we form a package of proposals: short term, long term and immediate - 1-3 countries by the end of 2024. 4.3.2. Based on proposals, finding partners and resources to implement pilot models of practical humane drug policy - for 1-3 countries by the end of 2024. 4.3.3. By early 2025, we plan to have resources for pilot programs with the support of key adequate MOH and drug control personnel; we agree that the pilots are conducted by and under the supervision of national organizations and the community.

	4.3.4. Inviting independent reputable experts to describe the results of community-managed pilots.4.3.5. After confirming the results of the pilots, working with governments so that the implementation of
